## **INFORMATION ON PERSONAL DATA PROCESSING Philang 2023**

Pursuant to Article 13 para. 1 and para. 2 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (Official Journal of the European Union L. 2016.119.1), General Data Protection Regulation, hereinafter referred to as "GDPR", please be informed that:

- 1. The Administrator of your personal data is the University of Lodz with its registered office in Lodz at Narutowicza 68, 90-136 Lodz.
- 2. In any case, you may contact the Data Protection Officer in writing at the abovementioned address with a note: Data Protection Officer of the University of Lodz or via e-mail: iod@uni.lodz.pl
- 3. Personal data: name (names) and surname, e-mail address, degree, and affiliation will be processed for the following purposes:
  - to register the participant, organise and conduct the 8th International Conference on Philosophy of Language and Linguistics, PhiLang 2023, organised on 12-14 May 2023 by the Department of English and General Linguistics;
  - to communicate with the Participants in matters related to PhiLang 2023, and document its process, including: preparing the Participants list and issuing the participation certificates;
  - to receive information on future conferences organised by the Department of English and General Linguistics on the e-mail address indicated in the application form.
- 4. Personal data will be processed on the basis of:
  - art. 6 (1) (e) GDPR in conjunction with art. 2 and 11 of the Law on Higher Education and Science of 20 July 2018 (as it is necessary to perform the task implemented in the public interest or within the authority granted to the administrator in connection with higher education and science mission regarding education, shaping civil society, participation in social development and creating innovative economy);
  - art. 6 (1) (b) GDPR (as it is necessary to execute the contract, where one of the parties is the data subject, or take action at the request of the person, who is the data subject, before signing the contract);
  - art. 6 (1) (c) GDPR (in conjunction with legal regulations and internal regulations at the University of Lodz);
  - art. 6 (1) (a) GDPR on the basis of your data processing consent (in the case of the consent to reproduce physical likeness or receive information on future conferences and events);

- 5. In the case when the data is processed on the basis of your consent, you have the right to withdraw your consent at any time without affecting the processing law, which has been made before the consent withdrawal.
- 6. Your personal data may be transferred to other authorised entities on the basis of relevant legal regulations and agreements made with the University of Lodz.
- 7. Your personal data will be processed for the period necessary for the implementation of goals indicated in point 3, and storing financial and accounting documents of the **PhiLang 2023 Conference** by the University of Lodz. In cases provided for by the legal regulations, your personal data may be processed during the period necessary to determine and pursue claims. In the case of giving consent to the reproduction of physical likeness or receiving information, your personal data will be processed until the consent is withdrawn.
- 8. You have the right to:
  - 1. access your personal data,
  - 2. request correction of your data, if the data is incorrect or inconsistent,
    - 3. delete, restrict or transfer data in cases provided for by law,
    - 4. object to data processing,
  - 5. file a complaint with the President of the Personal Data Protection Office, with its registered office at Stawki 2, Warsaw, Poland.
- 9. Providing personal data is voluntary, but necessary for the purpose referred to in point 3.
